Webinars, Blogs, Funding Guides and More:

The Federal Highway Administration (FHWA) has announced the **2022/Round 6 Designated Alternative Fuel Corridors** which "provide additional connections to highways designated in the previous five rounds of nominations to better complete coverage of alternative fuels nationwide." The 2022/Round 6 designations include 177 EV corridor-pending and six EV corridor-ready highways. The six corridor-ready designated highways are in Florida, New Jersey, and North Carolina. In NC, the EV corridor-ready highway is US70 between the I-95 interchange in Smithfield and the I-85 interchange in Durham. https://www.fhwa.dot.gov/environment/alternative_fuel_corridors/ready/.

The Federal Highway Administration (FHWA) has published a <u>Notice of Proposed Rulemaking (NPRM)</u> on standards and requirements for projects funded under the **National Electric Vehicle Infrastructure (NEVI) Formula Program**. Comments to the rule will be accepted until <u>August 22, 2022</u>.

NEW – The National Telecommunications and Information Administration (NTIA) is hosting a series of "office hours" for those interested in applying to the Enabling Middle Mile Broadband Infrastructure grant program. NTIA staff and subject matter experts will answer questions from all prospective applicants with the intent to prepare them to write high-quality applications. The sessions for local and regional governments will be held on Tues., August 30 and Thurs., September 1 from 2 to 3 p.m., EST, respectively. Register, here. Registrations must be completed by Noon the day before the desired session. The deadline to apply to the Middle Mile grant is September 30, 2022.

The U.S. Conference of Mayors, the National League of Cities (NLC) and Results for America announced a new **Local Infrastructure Hub** that will provide \$50 million to aid cities and towns in accessing billions in federal infrastructure funding. Through the hub, experts will provide "free coaching, data analysis and support" in helping applicants with their grant applications. The hub, which is funded by Bloomberg Philanthropies, Emerson Collective, Ford Foundation and The Kresge Foundation, launched on July 12, 2022.
