Highlight:

The Department of Homeland Security (DHS) and FEMA posted the **FY22 State and Local Cybersecurity Grant Program (SLCGP)** – DHS-22-GOD-137-00-01 - this week. This first-of-its-kind grant has an estimated funding that is over \$184 million. The SLCGP, along with the Tribal Cybersecurity Grant Program (TCGP) will help eligible entities address cybersecurity risks and threats to information systems owned or operated by—or on behalf of—state, local and territorial (SLLT) governments. The Notice of Funding Opportunity for the TCGP will be released at a later date. The deadline to apply is November 15, 2022.
