The Energy Communities Interagency Working Group (IWG) of Coal and Power Plant Communities and Economic Revitalization released the updated **eligibility maps for the 10% Bonus Tax Credit**. More information and to access the map, [here](#).

The [Southeast Crescent Regional Commission \(SCRC\)](#) has *extended the deadline* to submit a required pre-application for the new [State Economic and Infrastructure Development \(SEID\) grant](#) to **September 15, 2023**. Specific North Carolina communities are located within the SCRC footprint and have grant eligibility. More than \$4.4 million in funding has been allocated as North Carolina's share of the overall \$20 million in total funding.
