Webinars, Blogs, Funding Guides and More:

The Energy Communities Interagency Working Group (IWG) of Coal and Power Plant Communities and Economic Revitalization released the updated **eligibility maps for the 10% Bonus Tax Credit**. More information and to access the map, <u>here.</u>

NEW – Grants.gov will be down for maintenance October 21-23, 2023.

NEW – The NC Department of Information Technology (NCDIT) is seeking information from stakeholders statewide on what North Carolinians need to **access and afford high-speed internet**. Two surveys, which will inform the state's Digital Equity Plan, are available; they are the Digital Equity Survey and the Asset Inventory Survey. The <u>Southeast Crescent Regional Commission (SCRC)</u> has *extended the deadline* to submit a required pre-application for the new <u>State Economic and Infrastructure Development (SEID) grant</u> to <u>September 15</u>, 2023. Specific North Carolina communities are located within the SCRC footprint and have grant eligibility. More than \$4.4 million in funding has been allocated as North Carolina's share of the overall \$20 million in total funding.

The U.S. Department of Agriculture (USDA), in conjunction with the U.S. Department of Energy (DOE), the U.S. Department of Treasury, the U.S. Environmental Protection Agency (EPA) and the Economic Development Agency (EDA), released <u>two new pocket guides to assist rural stakeholders</u> identify funding opportunities (many provided by the Inflation Reduction Act) for workforce, climate-smart and resiliency investments. The guide, organized by potential uses, is in <u>English</u> and in <u>Espanol</u>.

The U.S. Department of Agriculture (USDA) and Rural Development division developed <u>an FAQ website specific to</u> <u>the Inflation Reduction Act and the new PACE (Powering Affordable Clean Energy) Program</u>. The <u>PACE loan</u> <u>program</u> is for communities with less than 20,000 population. LOI's will be reviewed on rolling basis. Accepted LOIs will be invited to apply. LOIs are due by September 29, 2023.

NEW -- The U.S. Department of Energy (DOE) is hosting a webinar on the <u>Technology Liftoff Funding Opportunity</u> <u>Announcement (FOA) and updates to the Demonstration and Validation FOA</u>, both of which are offered through the DOE's Office of Electricity. The webinar is <u>August 29 from 1 to 2 p.m. EST</u>. Register, <u>here</u>.

The U.S. Department of Energy (DOE) released a map "<u>Energy Community Tax Credit Bonus,</u>" which can help communities understand their qualification status and the benefits they can expect from this tax credit for advancing clean energy initiatives. NEW -- The U.S. Environmental Protection Agency (EPA) is hosting a webinar series on the <u>Diesel Emissions</u> **Reduction Act (DERA) grant NOFO**. The webinars are on Wed., August 30 at 2 p.m. EST (join, here) and Thurs., September 14 at 6 p.m. EST (join, here). The deadline to apply for a DERA grant, which includes FY22 and FY23 funding, is December 1, 2023. The U.S. Environmental Protection Agency (EPA) released a Clean Water Act / National Pollutant Discharge Elimination System (NPDES) Integrated Planning Toolkit for Permitting Authorities assisting permitting authorities to review integrated plans and incorporate them into permits. Additionally, EPA is offering <u>free technical assistance</u> (TA) to municipalities and permitting authorities to support the integrated plan development and review process.
