Webinars, Blogs, Funding Guides and More:

NEW – The Federal Emergency Management Agency (FEMA) of the U.S. Department of Homeland Security (DHS) is seeking public input on ways it can <u>simply the management and administration of prepardedness grant programs</u>. Submit comments by 5 p.m. November 7, 2023, <u>here</u> or by <u>emailing here</u>. Additionally, two public listening sessions will be held on <u>September 14 at 3 p.m.</u> (register, <u>here</u>) and <u>September 20 at 3 p.m.</u> (register, <u>here</u>).

Grants.gov will be down for maintenance October 21-23, 2023.

The U.S. Department of Agriculture (USDA) and Rural Development division developed an FAQ website specific to the Inflation Reduction Act and the new PACE (Powering Affordable Clean Energy) Program. The PACE loan program is for communities with less than 20,000 population. LOI's will be reviewed on rolling basis. Accepted LOIs will be invited to apply. LOIs are due by September 29, 2023.

The U.S. Department of Energy (DOE) launched the <u>Community Energy Innovation Prize</u> that will award up to \$7.5 million in cash prizes to organizations "supporting innovation, entrepreneurship, capacity building, and economic development in communities historically underrepresented in climate and energy technology funding." The Community Energy Innovation Prize is the successor to the Inclusive Energy Innovation Prize and the Community Clean Energy Coalition Prize. This new Prize has three separate tracks, <u>each will different deadlines.</u> An introductory webinar on the Community and Manufacturing Ecosystem tracks will be held on October 10 at 3 p.m. EST. Register, here.

The U.S. Department of Energy (DOE) will host a webinar on the <u>Transmission Siting and Economic Development</u> grant on September 14 at 2 p.m. EST. Register, <u>here</u>. The deadline to submit a concept paper is October 31, 2023. Full applications are due April 5, 2024.

The U.S. Department of Energy (DOE) launched the <u>Advanced Cybersecurity Technology (ACT) 1 Prize competition</u> which is part of the Rural and Municipal Utility Cybersecurity (RMUC) Program. This program will provide \$250 M over five years to "enhance the cybersecurity posture of cooperative, municipal, and small investor-owned electric utilities." The \$8.96 M ACT 1 Prize is the first in a series of prizes from the RMUC program. Applications are due November 29, 2023.

The U.S. Economic Development Administration (EDA) is hosting "office hours" for the new <u>Distressed Area</u> <u>Recompete Pilot (Recompete)</u> grant program, which has an <u>October 5</u>, 2023 deadline to apply. The remaining webinars are:

The U.S. Environmental Protection Agency (EPA) and the U.S. Department of the Army will host a series of webinars on the <u>final rule related to the recent Supreme Court decision in Sackett v. EPA</u> which defines "waters of the United

New (updated) -- The U.S. Environmental Protection Agency (EPA) released a <u>new guide</u> as part of its <u>Climate</u> <u>Pollution Reduction Grants (CPRG) program</u>. The guide outlines funding opportunities for local governments (and others) for the development of climate action plans under the CPRG. Note, the second phase NOFO's of the CPRG program (implementation phase funded at \$4.6 billion) will be released in <u>September 2023</u>. A webinar on an update of the next phase of the Climate Pollution Reduction Grants program will be held <u>September 21</u> at 2:30 p.m. EST. Register, <u>here</u>.

The U.S. Environmental Protection Agency (EPA) is hosting a webinar series on the <u>Diesel Emissions Reduction Act</u> (<u>DERA</u>) <u>grant NOFO</u>. The last of the series is <u>Thurs.</u>, <u>September 14 at 6 p.m. EST</u> (<u>join</u>, <u>here</u>). The deadline to apply for a DERA grant, which includes FY22 and FY23 funding, is <u>December 1</u>, 2023.
